Neighborhood Improvement Program canceled for 2010 The City of Monterey is facing a \$5.3 million dollar deficit

In an unprecedented year, the Monterey City Council and the Neighborhood Improvement Committee has unanimously voted to suspend the Neighborhood Improvement Program for one year.

Last year, NIP contributed \$400,000 toward the budget shortfall. This is the first time the program has been completely suspended since its formation by the voters of Monterey in 1985. The suspension underscores how serious our economic situation has become. Monterey is facing a budget deficit of more than \$5 million dollars in the coming year. This economic recession is affecting every city in the United States, and most of the other cities have much bigger problems than we do.

To ensure the continued services to seniors and children all the neighborhoods in our city are willing to make these sacrifices. All City of Monterey departments are facing severe cutbacks including our Library. City of Monterey employees are being asked to make major financial concessions to help balance this budget.

The projects submitted for this year's neighborhood improvement program will be included into next year's program. All the neighborhood traffic calming projects in the city are still on hold.

We can expect reduced city services for the next few years to come; therefore we will all have to have extra patience in waiting for responses to our needs.

CONA Neighborhood Watch

It is important for you to have contact information for your immediate neighbors. Strangers in the yards? Unusual activity? Let's stop crime before it becomes a problem. You may print extra copies of the neighborhood watch cards from our website <u>www.cona.info</u>. Spend a few minutes with your neighbors and fill out each others cards.

Recently there has been a string of automobile burglaries in the City of Monterey. As we are writing this copy we received a call that a vehicle on Edinburgh was broken into on the night of the March 19th. A window was shattered and property stolen. In the rest of the city a pattern of thefts has emerged in which mostly unlocked cars are targeted, large numbers of them.

Both Dry Creek Road near Skyline in Monterey and New Monterey have had many incidents. Unlocked cars allow thieves access to the interior of the car, the glove compartment and in most cars the trunks lock release. They are looking for high value, easily grabbed cell phones, laptops, cameras and brief cases. We are talking about well over a dozen cases a night in each of those locations.

The Monterey Police warn residents to not leave valuables visible in their parked cars and to always lock the car. Please be aware that this is a current and ongoing problem.

The police also urge residents to lock all doors and windows of their homes.

Unlocked, they are the favored method for burglars to gain access to homes. So many seniors developed the habit of leaving windows ajar for air circulation, never locking them. Thieves are well aware of their habits. The prime time for ordering new security alarm systems is always the day after a breakin. It is time for all of us to re-look at our old habits.

CONA 2010 Annual Meeting

The CONA neighborhood revitalization plan has been delayed for a few years. CONA and the City of Monterey staff have been working towards getting this program up and running. The plan will be presented to you at the Annual meeting on April 15th. It will then go to the City Council for adoption on May 4, 2010.

On our annual meeting agenda will be a presentation by the City of Monterey Housing Department of this plan. We will review the priorities that our residents came up with three years ago and see if we need to amend them.

Adoption of the Revitalization plan allows the City to focus existing CDBG (Community Development Block Grants) entitlement funds in the CONA neighborhood, allows use of CDBG rehabilitation funds to assist some Moderate Income households with grants and low interest loans, not just Low Income households, allows continued CDBG funding for the Code Enforcement Officer with 50% of time spent in Revitalization area, allows CDBG funding to be used for commercial/economic development loans or grants without extensive administrative costs associated with monitoring job creation (can benefit N.Fremont Street businesses adjacent to the CONA neighborhood). Adoption of the plan also can assist or place the City in better position to capture future Federal or State grants that might be offered and targeted to the Plan area. Improves our competitiveness in grant applications.

An immediate benefit is that the HPM staff is already recommending \$20,000 CDBG in the next fiscal year to be targeted for neighborhood remodels, repair and/or beautification. Neighborhood input will be requested to prioritize how the funds are spent.

We will have a short presentation from the Sgt. Frank Russo of the Monterey Police Department on the CONA Neighborhood Watch. There will be an emphasis on methods we can use to prevent crime in our area.

David Wright, Monterey's Code Enforcement Officer will be at the meeting to address any issues or questions regarding city codes.

We will also discuss what type of neighborhood events everyone would like to see for this year. We need more volunteers to step forward to organize and put on these CONA events.

Please note that the N. Fremont Street Specific Plan meeting is on April 7th.at the Fairgrounds. That meeting is to determine how mixed use commercial will be adapted to that street. The COPPS meeting is on April 22.

The Casanova Oak Knoll Neighborhood Plan update is scheduled to start this year. The last one was completed in 1985. That Plan stood the test of time protecting our neighborhood. We need that same type of vision to be translated into the new Plan. It will be a busy year for everyone.

CONA sends out email update notices during the year. We do not have the resources to print and distribute multiple flyers; we use email to get neighborhood watch alerts and current neighborhood information to our members. If your email address has changed please send the new one to <u>conamonterey@aol.com</u>. When it comes to watch alerts we have to rely on neighbors informing other neighbors. So when you get one, think of those around you that may not have computers and pass the word.

The City of Monterey now has the ability to make automated calls in emergencies through the County's Reverse 911. This system was used last month to warn residents to stay away from the shoreline because of the Chilean tsunami alert. This system will play a very important role in future emergencies.

Remembrances of CONA history

Picking up from the August 2009 newsletter we left off reminiscing on the South side of N. Fremont Street. Now to the North side of the street.....

Starting at Canyon Del Rey heading toward Monterey:

The P.G. & E substation was always there along with the little cottages on Casanova. These cottages are reserved by P.G.&E. employees who vacation here with their families.

During the fifties there were several vacant lots on this side of Fremont. At the time the name of the street was Fremont Boulevard.

Norma Jeans was a liquor store.

The present Monterey Produce was the Wishing Well diner. Out in the front they had a well with a roof overhead to complete the "Wishing Well concept". Many of the CONA original residents dined there. In the fifties they had a hamburger contest; if you broke the record your meal was free. A sergeant from Fort Ord broke the record with 19 hamburgers.

Big 5, previously was Griffiths unfinished furniture, and before that it was Dores superstore, a furniture and appliance store, originally it was Union Furniture.

The present Gem store, was preceded by the Pink Elephant liquor store, do you remember the giant plastic pink pig on a free standing sidewalk mounted sign?

Monterey Bay Pet Hospital was actually functioning with a Vet for decades, now it is just rotting into the ground.

Monterey Lanes Bowling Alley was constructed in the mid fifties and competed with Cypress Bowl.

Monterey Cookhouse, was preceded by Point Joes, Monterey Joes, and originally Shakeys Pizza

Chef Lees was previously a Sambo's pancake house


