**Fairness and equity of city services should be taken very seriously.** Almost a year ago the City sent surveys to every CONA home here, and a Town Hall meeting was held at the Park Center. The top priority (92 CONA residents responded) was a preschool, followed by afterschool programs and Special Events. So far none of these resident priorities have been implemented. The City is asking for \$2 million dollars to remodel Hilltop Center (open since the Pandemic over 3 years) while our Park Center has been closed over 4 years. Equity?

The only program listed for this year is a Fencing Class? Not one resident requested this in the survey. Monterey is in severe financial distress, our City buildings are in horrible condition, while revenues are soaring but expenditures are going up even faster. Please do not listen to promises, only results, which are not there. Change is in your hands in your votes. Forty years ago when we formed CONA we coined the phrase "we are the stepchildren of Monterey", last to get city services, first to lose them. Nothing has changed!

#### Neighborhood Community Improvement Program (NCIP)

**In Process,** Mark Thomas Bike/Pedestrian project is approved and in design. With the N. Fremont GAP project Casanova to Canyon Del Rey, will tie our bike lane with separated bike paths of over 50 miles FORTAG. TAMC is taking the lead on getting a grant for the GAP.

The exterior cyclone fence at the Park is approved and out for bids, construction will begin very soon. Without the NCIP our neighborhood would have zero progress, the Council now wants these funds.

**Proposed this year....**Sidewalk infill on Melway Circle (2), also sidewalk infill on Ramona from Edinburgh to Stuart, and lastly two replacement Radar Speed signs on Airport Rd.

**In this ever-changing time, the one constant unifier we have is our neighborhood association. It is more important than ever; we need to band together and speak in one voice!**
