Attention: All Casanova Oak Knoll residents.....an active Neighborhood Association is more essential than ever. Government meetings that can affect your lives and your property are being held daily. Monterey agendas come out after 5:00 pm on Fridays for meetings on the following Tuesday. Three day notices for information that must be digested and dispersed to you. Without an association you would only find out afterward, too late. Your association is here to inform you, tell you of upcoming events such as parking enforcement.

Last December this neighborhood sustained unprecedented damage from a historic windstorm. As far as we know we were the only neighborhood surveying the damages.

The City has stated that they there are no business changes on N. Fremont. Inflation, an enormous increase in construction costs and a horrible economy have delayed N. Fremont progress. The CVS corporation has declared bankruptcy but has not stated the plans for their store here. The Mark Thomas Bikeway is under construction design, it and the GAP project still need actual construction grants.

IMORTANT NEWS UPDATE PLEASE FILL OUT APPLICATION FORM LEGIBILY

The **City of Monterey is monitoring all city streets for vehicles parking over 10 days that do not move.** This is citywide; vehicles that have not moved get a fine citation. This has nothing to do with the Fairgrounds Program. Every Monterey street is monitored to keep people from storing vehicles on city streets.

The Monterey Airport has adopted a voluntary night flight curfew. It is not mandatory. The last incoming commercial aircraft is at 11:59 pm. The first commercial jet takeoff is 5:00 am., followed by two more at 6:00 am. If you want this changed please bring it up at the meeting. Private planes take off and land all night long. Some residents object but near an equal number desire more flights. Jet fuel odor in our air is reported to us often. What is your opinion?
